- The importance of defining specific deliverables for 2023, getting the messaging right and engaging the right people including the private sector.
- Ensure we are maximising synergies between Missions, with CEM initiatives, and Breakthrough Agenda

Secretariat to work with Missions to develop a list of concrete actions (“what we will do”) or outcomes (“the impact we have had”) to showcase at MI-8 and COP28, building on the Action Plans and Sprints launched at MI-7. MI Sec to consolidate list of achievable Mission actions and announcements in a one-pager.	One-on-one conversations in early May 2023 . One-pager by mid-June 2023 .

Monitoring Progress (1)

At the Annual Gathering we set out to:

- Agree on mechanisms and metrics that MI will use to track progress, including through an annual TAG review of Missions
- Define MI's role in tracking progress of global clean energy innovation activity such as demonstrations

What we heard at the Annual Gathering:

- **TAG** - General support from Missions on review plan, with some feedback to consider
- **Insights** – Take on board feedback on how the Hub should be developed to be most valuable for the MI community, reflecting on the reporting process in 2022 and determining updates

Finalise strategy for Insights module	Finalise document summarising Insight module overarching strategy, drawing on planning from MI 2.0 and outlining how workstreams (such as Hub and Think Tank) help meet MI objectives.	Update MISC before MI-8
Design and establish the Energy Innovation Metrics Hub	Activities in train to scope requirement for the hub.	Have requirement scoped by end of May , then look for funding mechanism and supplier. Depending in procurement route, look to start building of hub to have a prototype by COP28 .

Produce the Member Insights Report 2022-2023 based on the MI Member Survey responses	MI Members will answer the yearly survey on their national innovation programmes and initiatives that have taken place over the past year, where they are collaborating with the private sector and internationally, and how they interact with the MI.	Survey sent out early September 2023 , responses to be submitted by mid-October 2023 , the report produced for COP28 .



Extending our Reach and Impact (1)

At the Annual Gathering we set out to:

- Identify Missions Comms needs and clarifying branding architecture
- Agree on an approach to extending MI's reach (COP28, other initiatives, G20)

What we heard at the Annual Gathering:

- Need for clarification on the comms plan and MI narrative
- Importance of considering key moments across the year collectively (G20, COP, role of MI-8) to maximise impact
- Consider different ways to extend MI's reach and impact including extending membership and involving non-members

What we will do next:

Approach countries that are in missions but not members to gauge interest	Inform Mission Directors that MI Sec will be doing this. Ask for feedback on the level of engagement of these countries. Approach the countries where relevant.	End of May 2023
Clarifying the road to membership, with instructions for countries with specific circumstances, such as multiple ministry involvement. Consider new status for observers.	Review existing guidance considering the position of interested countries. Review governance document to include a path for an observer status for countries that demonstrate commitment to MI 2.0.	End of May 2023
Consider Task Forces for MI Narrative and activity at COP28	Begin engaging with members that would be interested in being on the Task Force, develop ToRs	End of June 2023
Modernise MI website	Scope requirement and seek procurement routes.	End of June 2023

Implementing the Missions and Equipping for Success

- Follow up on resource commitments to Missions to ensure actions and outcomes in 2023 are impactful
- Maintain political / minister-level awareness of Mission activities and MISC strategic input on Missions
- Review and provide feedback on Mission deliverables for Goa and COP

- Consideration of the hub and think-tank proposals and contributions from members to activities as relevant

Extending our Reach and Impact

- Funding for website
- Consider volunteering to be on the COP28 and/or narrative task force.
- Encourage members to take forward MISC agreed approaches to extending reach and increasing impact



MI-8 Goa, India – 19 to 22 July 2023

- **Venues & Access:**

- The CEM and MI Ministerial will take place at the **Grand Hyatt, Goa**; the CEM and MI Side Events will also take place at the **Grand Hyatt, Goa**.
- The MI and CEM events will be open to registered delegates for MI-8.
- The G20/ETMM Negotiations and Ministerial will take place at the **Taj Resort & Convention Centre, Goa**. The ETMM events will be open to G20 Delegates only.

- **Capacity:** The expected maximum capacity of the facilities at the **Grand Hyatt, Goa** is 600, which also include Ministerial delegations (Minister + 2)

- **Joint CEM/MI Programme:**

- Joint Plenary meeting for Ministers, Heads of Delegation, High Level Guests (21 July)
- Opening ceremony, roundtables, press conference and closing ceremony (21 July)
- Ministerial Roundtables – Six roundtable discussions between Ministers and private sector representatives (topics under consideration) (21 July)
- Select Side Events – Under consideration by CEM/MI Secretariats in conjunction with Hosts (19 to 22 July)

- **Side events (MI+ CEM):** possibility of organising up to twelve side events of 90 minutes on each day. MI received 30 expressions of interest. These are being screened in conjunction with CEM. Preliminary selection of side events is likely to be completed by **15 May 2023**.

MI-8 Goa, India – 19 to 22 July 2023

- **Virtual/hybrid participation:** At present only physical participation.
- **Invitations**
 - Ministers/Heads of Collaborating Organisations will receive personalised letters from Govt of India by **15 May 2023**.
 - Senior Representatives/other delegates will be invited to register once the registration opens.
- **Registration**
 - The Secretariat will provide a list of MI points of contact to be invited to register.
 - The registration will open by **22 May 2023** and close on **21 June 2023**.
- **Logistics**
 - Procedures for Hotel bookings, process of visa letters, registration and accommodation (Logistic notes) will be shared by **26 May 2023**.
- **Communication**
 - **Website:** Under development and will be launched by **20 May 2023**.
 - **Branding:** An event logo will be launched by **20 May 2023**.

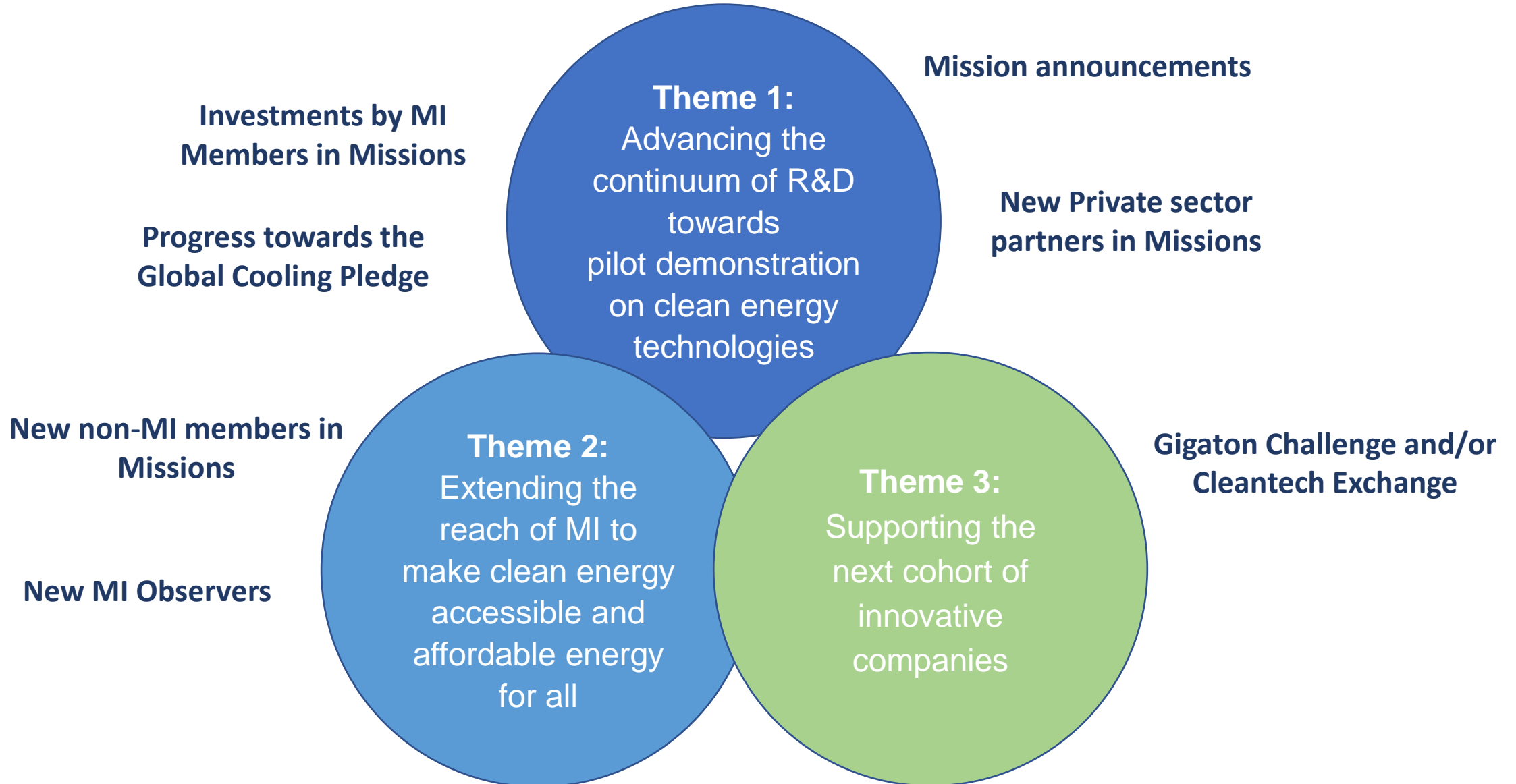
